### (a) Other Disposal - Díuscairt Eile

(i) Proposed by Cllr. P. Millea, Seconded by Cllr. T. Maher and agreed "That Kilkenny County Council, hereby approves in accordance with Section 183 of the Local Government Act, 2001, to dispose of

lands, as indicated on the attached map, at Rathclogh, Co. Kilkenny to Ann Gibbons, Kilree, Bennettsbridge, Co. Kilkenny for the sum of €100 with each party being responsible for their own legal costs in accordance with the terms specified in the notice."

### (c) Roads - Bóithre

(i) <u>Notification of Grants Allocations for National and Non-National</u> Roads.

Mr. John Mulholland referred to report which had been circulated with the agenda. Notification of roads grants allocations were received at the end of Jan 2012. Total grant allocation for Kilkenny County Council is €17.7m, a reduction of €4.6m due to completion of work and land purchases on the M8 and M9 motorway schemes.

He requested members approval for alteration of allocations between projects being funded under pavement and minor works. It is proposed to re-allocate funds to Hennebry Cross Roundabout construction scheme from other projects in this category.

It was proposed by Cllr. C. Connery, Seconded by Cllr. T. Maher and agreed "to approve the re-allocation of funds between the five schemes listed for national secondary pavement and minor works."

Contributions were received from Cllr's T. Maher, J. Coonan, J. Brennan, M. Brett, P. Dunphy, F. Doherty, C. Long, M. Shortall, C. Connery, T. Breathnach, E. Aylward.

Members welcomed the allocation in general for 2012, especially for projects that have been planned for a number of years such as Tennypark, Hennebry's Cross and Ballinaslee.

Issues raised were as follows:-

- Status of number of projects whether at planning, land purchase or final design and where money will be spent.
- Acquisition of land by agreement or CPO.
- Details of Low Cost Safety Improvement Works
- Has there been reduction in cost of works?
- Nominal allocation for Carrick Road, Mooncoin, Co. Kilkenny.
- Funding for repairs following severe weather.

Mr. J. Mulholland responded to all queries raised and outlined to members the process involved in bringing a project from outline design to planning, land purchase/CPO to final design. He advised that delays can be encountered with Archaeology, CPO and An Bord Pleanala.

It was proposed by Cllr. P. Dunphy, Seconded by Cllr. F. Doherty and agreed that Kilkenny County Council should write to the Dept. of Transport, Tourism and Sport seeking recoupment of money spent on Roads in 2010 due to severe weather.

# (ii) <u>2012 Special Speed Limit Bye-Laws – Recommendation for Resolution of Council for adoption following statutory consultation processes.</u>

Mr. J. Mulholland referred to his report dated 9<sup>th</sup> February, 2012 circulated to members recommending adoption of the Special Speed Limit Bye- Laws 2012. The changes to the Bye-Laws have been highlighted for ease of reference. The report outlines that the review was carried out in accordance with Section 9 of the Road Traffic Act 2004.

Cllr. M. Fitzpatrick requested that the relevant signage be erected as soon as possible.

It was proposed by Cllr. M. Doran, Seconded by Cllr. S. Treacy and agreed "That the County Council of the County of Kilkenny with regard to the powers conferred on them by Section 46 of the Road Traffic Act 1961, as inserted by Section 33 of the Road Traffic Act, 1994 and Section 9 of the Road Traffic Act, 2004 and with the consent of the National Roads Authority, hereby make Special Speed Limit Bye Laws in respect of the area comprising of the administrative County of Kilkenny in accordance with the report attached and forwarded to members on the 9th February, 2012."

### (iii) Abbeypark Bus Stop – Part 8 Report and Recommendation.

Mr. J. Mulholland advised members that screening assessment had been carried out and outlined that the project was advertised in accordance with planning legislation. The location of the bus stop has been agreed in consultation with the residents.

Cllr's A.M Irish, E. Aylward, T. Breathnach, C. Long welcomed the progress being made on the provision of the bus stop.

It was proposed by Cllr. T. Breathnach, Seconded by Cllr. C. Long and agreed that "We the members of Kilkenny County Council, having considered the report prepared in accordance with Part 8 of the Planning and Development Regulations 2001-2010 and Section 179 of the Planning and Development Act 2000-2010,

approve the provision of a bus access route and bus stop at Abbeypark Housing Estate."

Cllr. M .Doran requested the support of the Council in writing to An Bord Pleanala and the Dept of Environment, Community and Local Government in relation to the time period allowed for the Bord to make decisions on applications submitted by local authorities for small developments. The current timeframe indicated by the Bord is 18 weeks. This in addition to the statutory consultation period of 6 weeks would give rise to a determination period of almost 6 months in order to proceed with development. Therefore Kilkenny County Council should seek a reduction of this period to 10 weeks. Cllr. J. Galway seconded the proposal.

### (d) Planning - Pléanail

(i) <u>Managers Report on Submissions to Proposed Material</u>
<u>Alteration to Amendment 1 to the Ferrybank/Belview Local</u>
<u>Area Plan (2009).</u>

The County Manager advised the meeting that the proposed material alteration has been discussed at a number of meetings and that there are no major issues outstanding and he is recommending to the members that the proposed material alteration of Amendment 1 to Ferrybank/Belview Local Area Plan 2009 be adopted.

Cllr. A.M Irish referred to the commitment given at the last meeting to seeking a technical solution for sewerage facilities at Mullinabro/Cloone.

Cllr. T. Breathnach noted that progress is being made as he understands contact have been made with the residents. He referred to the level of grants available.

The County Manager advised the meeting that staff were working on a technical assessment and this would be available for the April meeting. It is then a matter for the Council to approve it and move it forward for funding.

It was proposed by Cllr. T. Breathnach, Seconded by Cllr. C. Long and agreed that "We the members of Kilkenny County Council, having considered the proposal to make Amendment 1 to the Ferrybank/Belview Local Area Plan 2009 under Section 20 of the Planning & Development Acts 2000-2010, and having considered the County Manager's Report as circulated on the 10<sup>th</sup> October 2011, (and the addendums of the 17<sup>th</sup> October 2011 and 21<sup>st</sup> November 2011), prepared in accordance with Section 20 (3)(c)(ii) of the above acts, and having considered that the Proposed Amendment should be altered in accordance with our

decision made at the meeting of Kilkenny County Council held on 19<sup>th</sup> December, 2011, having published the proposed material alterations on the 6<sup>th</sup> of January, 2012, having considered the County Manager's Report of the 13<sup>th</sup> February 2012, prepared in accordance with Section 20 (3)(d) of the above acts on the submissions to the proposed alterations at the meeting of Kilkenny County Council held on the 20<sup>th</sup> February 2012, do hereby consider that the Ferrybank/Belview Local Area Plan should be amended in accordance with the procedures under Section 20(3) of the Planning & Development Act 2000-2010 and with our decision made at a meeting of Kilkenny County Council held on the 20<sup>th</sup> February 2012". (The Amendment being the proposal published as the "Proposed Amendment" as modified by resolution of the Council 19<sup>th</sup> December 2011."

### (e) <u>Finance - Airgeadais</u>

### (i) <u>Economic Development Policy – Invest Kilkenny update</u>

The County Manager updated the members on the initiatives been undertaken under Invest Kilkenny. There are six strategies being developed.

- 3<sup>rd</sup> level TSSG project in St. Kieran's College
- Food Strategy Milk Supply and Harvest 2020, assisting SME's in export food market.
- Tourism Preliminary approval received to four projects in "Medieval Mile" in Kilkenny City.
- Pharma/Life Science wet industries at Belview.
- Focus on exploring opportunities in China and India.
- Jobs recent government announcement on the establishment of local enterprise offices in local authorities and the dissolution of County Enterprise Boards.

He requested approval of members to review consultation with the business community in order to review the direction of the Economic Development Plan.

Cllr. P. Cuddihy expressed thanks on behalf of all the members to the Manager and staff for all the work undertaken to promote economic development in the City and County.

### (ii) Proposed Memorandum of Understanding with Suzhou Economic Development Zone

The County Manager referred to the Memorandum of Understanding with Suzhou Economic Development zone

which has been circulated to the members. Approval of the members is required and the memorandum will be signed on April  $2^{nd}$ , 2012.

It was proposed by Cllr. B. Ireland, Seconded by Cllr T. Maher and agreed "That Kilkenny County Council sign the memorandum of understanding on establishing a sister – city between the County and City of Kilkenny of Ireland and Suzhou new District of the People's Republic of China."

Contributions were received from Cllr's T. Maher, B. Manning, Ml. O'Brien, P. Dunphy, T. Breathnach, C. Connery, P. Crowley and P. Cuddihy.

Members welcomed the progress made to date so that Kilkenny can avail of new opportunities. There should be a focus on jobs creation and tourism within the County. Concerns were expressed in relation to human rights in China.

The County Manager thanked the members for their remarks. The document will be in English, Irish and Chinese.

#### (f) Water Services – Seirbhisí Uisce

(i) <u>Irish Water/Reform of the Water Sector in Ireland,</u> <u>Consultation Paper/January 2012</u>

Mr. Philip O'Neill made a powerpoint presentation outlining that submissions on the Consultation Paper for Irish Water should be made by the 24<sup>th</sup> February, 2012. He briefed the members on the proposed functions of Irish Water, the timeframe for transfer of services to Irish Water and the impact of this transfer of service for local authorities.

Contributions were received from Cllr's M. Doran, F. Doherty, Ml. O'Brien, J. Galway, T. Breathnach, M. Brett, P. Dunphy, S. Treacy, J. Coonan and T. Maher.

Members expressed concerns about how this new organisation will work, loss of functions/powers of local authorities, procedures for updating members on issues, point of contact for reporting breaks and response service for emergencies and transfer of staff. The name of the new organisation should be in Irish, as there may be confusion in the similarity of name of the Irish Water Safety Association.

Mr. P. O'Neill advised that the views of the members will form part of our submission. The transfer of functions will be over a long period – possibly to 2017. All entitlements/rights of staff will have to be protected. It was agreed to circulate the presentation to all members.

### (g) <u>Corporate - Gnóthaí Corparáideacha</u>

(i) <u>Fáilte Ireland Briefing re: Destination Kilkenny Tourism</u> <u>Strategy</u>

Cllr. P. Cuddihy welcomed Gary Breen and Amanda Horan to the meeting.

Mr. Gary Breen made a powerpoint presentation on Kilkenny Tourism to the members. The presentation outlined the current trends/statistics for tourists in Kilkenny and South East. Information was given on the strategies developed by Failte Ireland to promote destinations, attract tourists etc.

The County Manager thanked them for their presentation and their work in promoting Kilkenny as a tourist destination.

Contributions were received from Cllr's T. Maher, C. Connery, S. Treacy, C. Long, E. Aylward, T. Prendergast. Issues raised by members were as follows:-

- Development of over 55 market
- Focus on rural tourism in conjunction with Kilkenny City.
- River attractions

Ms. Horan advised that work have been carried out on promotion of the River Barrow and associated hub of Graiguenamanagh. The launch of this would be held shortly.

(ii) <u>Update on operation of the Watershed Sports and Leisure</u> <u>Complex</u>

Cllr. P. Cuddihy welcomed Mr. Billy Murphy and Mr. Dermot Gaynor to the meeting.

Mr. Billy Murphy thanked the Council for their invitation to make a presentation to them of the operation of the Watershed Sport and Leisure Facility.

Mr. Dermot Gaynor gave a powerpoint presentation outlining the highlights for 2011, increased activities, current financial position, plans for 2012 and long term issues which need to be addressed over the next few years.

Cllr. P. Cuddihy thanks them for the presentation and congratulated them on the progress been made in the development of an excellent facility.

Contributions were received from Cllr's M. Shortall, T. Maher, C. Connery and P. Cuddihy. Queries raised were in relation to the proposed cost of new track, widening the track, energy efficiency, linkages with Castlecomer Demense and Dunmore Caves for school tours.

The County Manager thanked them for their presentation and congratulated them and their team for operating a sport facility on a very effective cost basis with an operating surplus for 2011.

Contributions were received from Cllr's F. Doherty, P. Cuddihy, T. Prendergast, J. Coonan and C. Connery in relation to the two projects undertaken with local communities. Ms. Ledwidge was commended for her work in supporting communities to record local heritage.
