Anti Litter & Anti Graffiti Awareness Grant Scheme 2016 Report

22nd August 2016

Dear Ms Mulholland,

25 Anti Litter & Anti Graffiti Awareness Grant applications were received. The original closing date for applications (30th June) was extended to the 19th of August. The extension was deemed a fair way to ensure all community groups were aware of the grant deadline which was earlier this year than in previous years. It also permitted a reminder notification to be sent to groups who failed to apply and that are active in litter control locally. The grant scheme was advertised in the Kilkenny People and press releases highlighting the environmental grant available were published in both the Kilkenny Reporter and Kilkenny People.

The Department of Environment, Community and Local Government issued a circular LU 01.16 in February 2016 outlining the 2016 Anti Litter Grant Graffiti Awareness Grant Scheme for 2016 and in April, Kilkenny Council County returned a list of projects including the provision of the Community Litter Grant Scheme. The grant allocation by the Department was €17,850, 70% of the total cost of the project, the remainder must be met by Kilkenny County Council €7,650 (30%). Other projects financed by this grant scheme includes anti dog fouling awareness campaigns, roadside litter campaign, anti litter murals and the national spring clean.

Evaluation Criteria

- Groups completed & returned Appendix A. For 2015 grant recipients, Appendix A
 provided a breakdown of expenditure relating to the previous year's grant
 allocation. Groups listed completed works and costs associated with their litter
 control activities for the previous 12 months.
- Structure of Project Proposal
- Value for Money
- Project Cost Summary v's eligible activities as per Departments circular LU 01.16.

3 Unsuccessful Applications

Three groups were deemed ineligible for funding for the following reasons;

- Greens Bridge 250 Committee Insufficient information No ownership details or agreement with owner of affected property to complete the work presented with the application. The handball alley is listed on the National Inventory of Architectural Heritage ref no. 12000205. Any proposal to complete works on site should be completed in consultation with the Council's Conservation Officer. No evidence submitted to suggest the designation was considered or consultation took place.
- Lisdowney Dev. Ass Requested litter picking supplies only. No funding amount requested but asked for continued assistance with refuse removal during the NSC annually. Litter picking supplies will be provided to the group next spring.

 The Greens Residents, Thomastown – Amenity based application – no mention of litter disposal costs or litter control activities. This association is already in receipt of the Amenity Grant.

Recommended for Funding

After evaluating the applications, the committee (Bernadette Moloney & Michael Nugent) recommends that 22 community groups receive funding collectively totalling €13,295.
