Ms. C. Byrne advised that the members would receive a number of presentations. She advised the members that the problems regarding housing were not just arousing social housing and advised the members that there is a shortage of housing stock in general. She advised of the need to open up new neighbourhoods.

Mr D Malone gave a PowerPoint presentation on an overview of the current situation in relation to housing in general. In his presentation he outlined the following:-
