A full report will be produced next year at the end of the 2 year Implementation Plan. A workshop will be held towards to the end of 2019 to engage people to look at any issues and to work with a more integrated approach.

It was agreed that this could be a topic at the workshop due to be held at the end of this year.

Michael Delahunty Chief Officer gave an update on the LCDC's work programme. He advised that seeking to expand the number of Family Resource Centres and the need for new FRC's is a priority. Lindsey Butler is organising meeting with Marie Kennedy TUSLA.

SICAP - End of Year Review

Sheila Donnelly advised the committee that the SICAP Sub Group are meeting next Tuesday. Today the subgroup are seeking permission from the LCDC Committee to sign off on the 2019 Annual Plan and End of Year Review.

National Community Weekend

This is a new stream of funding announced by the Department of Rural and Community Development. €10,000 will be allocated for local community events over the May Bank Holiday weekend. It is an LCDC managed programme. The community section are waiting for further guidance from the Department. A subcommittee of the following people was agreed: - Niall McManus, Declan Gibbons and Eileen Ryan who will meet in February once the guidelines are received and revert back to the LCDC March meeting.

Citizen Engagement and promotion of Social Inclusion

PPN Report

Liz Dermody read out the report from the PPN. She reported the following:-

- Additional funding allocated for support worker to PPN
- To encourage further active participation under the Environmental Pillar the Secretariat is allowing all Tidy Towns groups to register under the Environmental Pillar as opposed to community pillar within Kilkenny PPN.
- The PPN is offering small grants for the St. Patricks Day Parade, applications are currently being received.
- Further interest has been expressed by several organisations in the business, hospitality and retail sectors for Kilkenny Access for all Programme.
- ➤ The venue for the Regional Environmental Conference of the PPN on February, 23rd is the Ormonde Hotel. This is an open conference and not exclusive to PPN registered members.
- A series of training workshops are currently being developed surrounding the areas Biodiversity and Natural Habitat conservation. These workshops will be rolled out during the months of February and March.

The PPN were commended on the great work being done.

Support Worker PPN

The Department of Rural and Community Development have allocated €25,700 for PPN Support Worker. Kilkenny County Council will also contribute €5,000 for a one year fixed term contract. Kilkenny County Council will be recruiting worker in conjunction with the Secretariat.

Items for Information and Information Sharing

Derval Howley shared information from the HSE to the group, including (COPD), Flu and Age Friendly initiatives.

Lindsey Butler updated the committee on the Lone parents Analysis; an interagency group has been established. Lindsey will send link to LCDC Members.

Michael Delahunty – Age Recognition Programme being lead by the Chamber of Commerce, leaflets have been sent to businesses and a training day will be held in the Ormonde hotel on the 19th of February.

Thomastown Town Plan should be finalised next month, hoping to get Age friendly status for Thomastown.

Also work being done on securing Age Friendly status in St. Lukes Hospital.
