Conversion of the school building includes for the closing of 3 no. high level windows facing onto east onto the N9 Dublin Road and the closing of 5 no. high level windows facing north into the existing courtyard. In addition to the converted school building the development consists of a 6sqm single storey extension to the boiler room, a 79sqm single storey portable cabin structure incubator unit, the use of the existing courtyard as an outdoor market for the sale of food goods to the public, the part demolition (6.5sqm) of single storey storage shed building to widen access to the courtyard, the establishment of 1,200sqm market garden within an existing grassed section of the site, the provision of 20 on-site parking spaces and a 4m wide hardsurfaced link road with separate footpath to link this carpark to the proposed Incubation Centre and the provision of a new site entrance off the N9 Dublin Road, all to be constructed with associated site services the site of the old Ladywell National School Cloghabrody Thomastown Co.
