The retention consists of the renovation works carried out in 2011, the reslating, repairs and treatment of the roof of the house, external plastering, and the inadvertent demolition of the south wing of the house, and the 'Cottages' service wing to the rear, the internal stripping out of the flooring on the ground floor, along with partial removal of flooring and partitions and fittings at first and second floor levels of the house, the reduction in levels of the yard and removal of site surfaces on the east and south sides of the building. The PERMISSION will consist of the renovation, restoration, and reinstatement of the house, the demolition of the bathroom addition, the re-building of the enlarged south wing, and new adjoining room, the demolition of part of the return to form a new bedroom and bathroom, the rebuilding of the 'Cottages' to the rear of the house, to hold living areas, services, a caretaker flat, and swimming pool, for a sewage treatment unit and raised percolation bed, for a new classical entrance gateway to the house, site works, ancillary works and landscaping.
